Maricopa County Audit Disappoints...

In typical QAnon fashion, many pundits on the right have been priming us for the massive indications of fraud the audit would provide. Predictably, in the aftermath of the release of the Arizona Senate's audit report, the left is claiming vindication, and the right is claiming there were enough anomalies to have affected the outcome of the election. The fact that the recount of the votes by the audit team was very close to the totals reported by the county is not surprising.

Recounts rarely flip the outcome, and then only when vote totals are small to begin with, but recounting the same ballots does not address whether the ballots were valid in the first place. The Cyber Ninja's report says, "On the positive side there were no substantial differences between the hand count of the ballots provided and the official election canvass results for Maricopa County. This is an important finding because the paper ballots are the best evidence of voter intent and there is no reliable evidence that the paper ballots were altered to any material degree." It would seem the story should end there, but what about the anomalies?

According to Maricopa County's results, Trump lost the county by 45,109 votes. Statewide, Trump lost by 10,457 votes. The Cyber Ninjas report lists total ballots impacted by each "Finding Name" (i.e., anomaly) in Volume III, page 5 of their [report](#). The total of all impacted ballots from all findings is 53,305, so the questions then become 1) what impact would removing all votes cast in violation of state election laws have had on the election, and more importantly, 2) how can we ensure that future elections do not have "anomalies" 5-times more than the margin of victory?

Steps must be taken to prevent ballot anomalies and make sure each vote counts and is counted only once. Legislatures around the country must enact stricter election integrity laws that make it easy to vote and hard to cheat. Arizona has never been regarded as a hotbed of voter fraud,

especially as compared to places like Chicago, Detroit, and Philadelphia.
