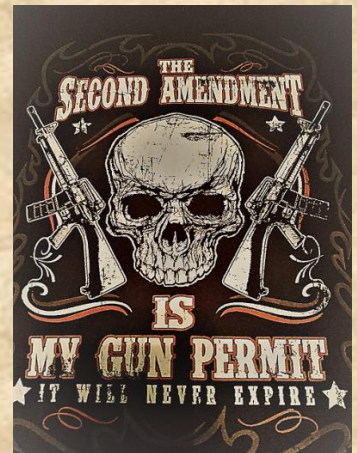

## Florida Constitutional Carry Update...

Last month I lamented the fact that Florida's Republican dominated legislature was making no effort to pass [HB 103: Carrying of Firearms Without Licenses](#) or to create a companion bill in the Senate and get legislation to the Governor's desk for his promised signature. There has been some movement on the issue, but it remains to be seen whether a bill is presented to the Governor. The Governor failed to specifically call on the legislature to pass specific bills to protect the right to keep and bear arms (i.e. enact Constitutional Carry, eliminate the "red flag" law, etc.). Instead he made a lukewarm statement saying, "I also recommend that the Legislature strengthen protections for Floridians' 2<sup>nd</sup> Amendment rights. These important rights should not depend on the whims of politicians who reject the existence of those rights."



Various gun groups such as GOA, FPC, and Florida Gun Rights (a subsidiary of NAGR) have been busy sending out updates and calls to action as has [Im4Rights](#). The Hillsborough County Republican Executive Committee along with Republican Clubs like the New Tampa Republican club have also urged their memberships to get in their legislators' ears and to contact legislative committee members in an effort to pass this initiative. It is an uphill battle despite Republican majorities as the House and Senate leadership has been actively putting the brakes on consideration of HB 103 or creation of a companion bill in the Senate. Recently it is being reported that the leadership is beginning to come around and would now support these efforts. Time is running out as we are about halfway through the legislative session. It is critical the Senate create and pass a companion committee bill now to put pressure on the House.

- Trauma first aid kit (camo)

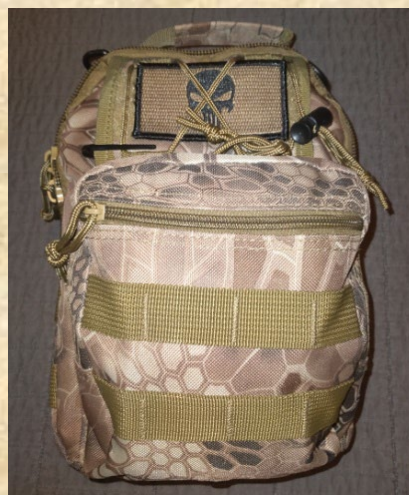


## Minimal First Aid Kit Contents:
